Calhoun County ISD Student Safety

The safety of students in CCISD is a top priority. The following actions have been taken to protect our students and ensure school violence prevention:

- Faculty and staff training on De-escalation, Mental Health Awareness, Threat Assessment and Emergency Operations Plans including Active Threat -- CRASE training led by the CCISD and Port Lavaca Police
- Character Education including Digital Citizenship, Positive Character Traits and Successful School Strategies
- Campus Directed Positive Behavior Interventions and Support
- Implementation and monitoring of Behavior Intervention Plans as needed
- Red Ribbon Week activities for drug prevention
- Anti-bullying campus campaigns, including prevention and reporting procedures
- Prevention programs on fire safety, bus safety, science lab safety, monthly fire drills drills and lockdown procedures
- Safety tips for students on daily announcements and wall displays
- Student presentations by the Harbor Children's Alliance and Victim Center and Mid-Coast Family Services
- Campus mail-outs to parents/guardians for verification of current addresses
- Emergency Operations, Communication and Reunification Plan - Parent Handout
- School Messenger, Classroom Remind and social media platforms for effective communication with families and communities
- Addition of a Student Support Resource Counselor to provide immediate support for students showing signs of struggle
- Additional Parent Liaisons to ensure parent communication and access
- UTMB T-CHAT online tele-counseling -- free and available for CCISD students
- Bi-Monthly Administrator Meetings to address CCISD Safety Protocols
- Surveillance cameras and communication radios on all campuses
- Camera stations for locked campus entries - visitors request entry
- Weekly door, camera and equipment safety checks by campus administrators
- Picture identification tags for faculty, staff and students
- Keyless school ID card entries and exterior fencing
- District-wide Raptor Visitor and Volunteer Management System
- An independent CCISD Police Department that works closely with the Calhoun County Sheriff's Office and local law enforcement agencies
- Additional Officers have been added to support all campuses
- Truancy officer works closely with the CCISD Police Department and local judges for attendance support
- District Safety Committee for the identification of campus needs
- CCISD comprehensive needs assessment developed by Board-Chaired County Partnership Safety Committee
- Visible hall monitors/safety specialists on campuses for student supervision
- HALO vape, THC and decibel detection devices installed
- Secondary parking lots monitored by campus administrators and canine unit
- District Threat Assessment Team -- monthly meetings and as requested by campus administrators
